## From the Pastor

Dear Friends,

The theme of the 190th celebration is from Psalm 126:3: *The Lord has done great things for us, and we are filled with joy.* The words invite our gratitude for all that God has done for us in the past and our confident hope in and heartfelt prayer for God's continuing faithfulness now and in the future.

Psalm 126 was one of the psalms sung by pilgrims going to Jerusalem to observe major religious festivals. As they worshiped, their focus was on God and on their own need for restoration and renewal—as believers and as a community of believers—in order to do what God called them to do.

Whether you have been a member of this congregation for decades or, you are, like I am, relatively new to First Presbyterian, you can undoubtedly see in this place the evidence of God's gracious abundance—and the response to it of God's people. The sanctuary, stained glass, and organ, for instance, were conceived of, given by, and maintained by people wanting to create something magnificent to represent and glorify God. The additions to the building over time reflected their commitment to grow God's kingdom in measurable ways. Ministries of compassion and service grew out of their experience of God's goodness. They could have dedicated their time and treasures elsewhere, but this church and its mission inspired their generosity. All of us are beneficiaries of their devotion and sacrifice.

Sometimes I think about the thousands of people who have worshiped in this church during the past 190 years—who sang their favorite hymns, made music, listened as the scriptures were proclaimed, pledged love during weddings, felt comforted during funerals, found purpose in acts of service, were baptized, grew in spiritual maturity, were ordained and installed to office, discovered God-given gifts they didn't know they had, established deep friendships, and claimed their identity as children of God. I marvel at the impact they surely had on the world, and I pray that we who now occupy the holy ground that is First Presbyterian Church, are able to do that with the passion and dedication of those who came before us.

The church and the world are different than they were two centuries ago. What has not changed, however, is God's faithfulness and our inherent need to respond in love, gratitude, and generosity to God. May we seek God's renewing power so that we can.

## World Communion Sunday

The first Sunday in October is designated as World Communion Sunday, which acknowledges our oneness in Christ with all our brothers and sisters around the world. During our worship service on **October 6**, the

Rev. Connie Bandy will preach and preside at the Lord's table.



We will celebrate the sacrament by intinction that day. To symbolize Christ's global reach and our connection to all God's children, servers will be in the four corners of the sanctuary to offer the bread and cup.

One of the stations will have gluten-free bread.

Also on that day, we will receive the Peace & Global Witness Offering. Your gifts will support church-wide ministries of peace and reconciliation (75%) and the local Peer Court program for youth (25%), which focuses on reconciliation and justice. Please give to support this innovative peacemaking effort.

World Communion Sunday is a gift of the Presbyterian Church to the larger ecumenical church. The first celebration occurred at Shadyside Presbyterian Church in Pittsburgh, PA, in 1933. Today, World Communion Sunday is celebrated around the world among many denominations.

## Session Highlights

Session met on September 17, 2019. Following are highlights of their meeting:

- 10 out of 12 elders present
- Approved suggestion from Deacons to include Good News Bibles in Christmas baskets
- Heard about follow-up visit from Fire Marshall in regards to compliance issues and reviewed status of bids for fire alarm system
- Approved letter of transfer for Marj and Rick Welchans to Waverly United Methodist Church in Waverly, Tennessee
- Accepted anonymous donation of 4 trees to be planted near property line on “North 40” lot north of the church building
- Approved lease agreement (with proposed changes) between the church and the Dwelling Place
- Approved purchase of Church Windows Management Software at cost of \$2,201, along with \$519 annual fee for use by Accounts Manager. Current accounts receivable/payable software is more than 20 years old and costs \$1995 annually. New purchase will pay for itself within 18 months.
- Approved that costs incurred for the 190th Celebration be paid from funds in Georgia E. Ward Trust and then Group Work Fund Savings Account

The next stated Session meeting will be **October 15**.

## Presbytery Report

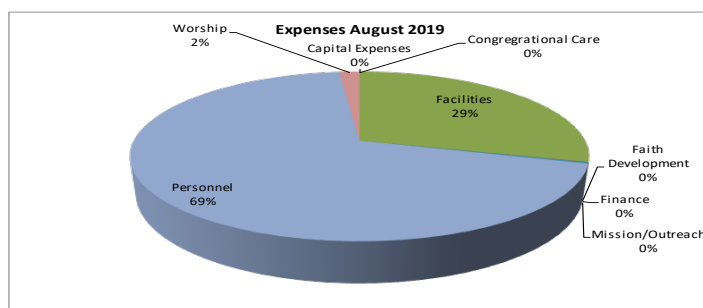
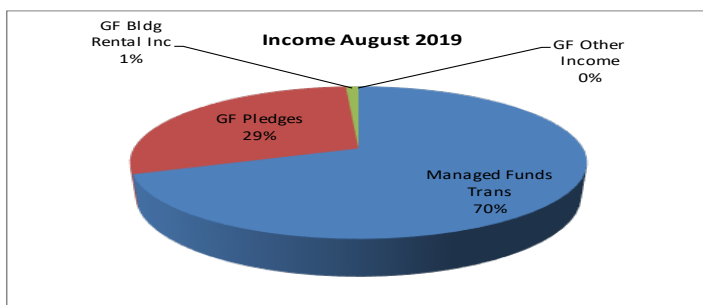
A stated meeting of the Presbytery of Southeastern Illinois was held on August 29 at First Presbyterian Church of Taylorville. Much of the meeting dealt with standard matters such as review of financials; comings, and goings; and updates of the General Council Manual for the Presbytery of Southeastern Illinois (PSEI). Donaldson Presbyterian Church and First Presbyterian Church of Golconda were recognized on the occasion of their 200<sup>th</sup> anniversaries. The Marion Medical Mission announced it is building 3,000 wells this year to provide clean, safe drinking water for people in Malawi. Rev. Jim Garrett gave an informative presentation on how Presbyterian Disaster Assistance (PDA) helps Presbyterians as well as others when disasters occur. PDA was “on the ground” within hours in Taylorville, Illinois, after the town experienced a tornado on December 1, 2018.

The PSEI adopted a Child and Youth Protection Policy at this meeting. In most instances it is very similar to the one adopted by First Presbyterian Church Danville (FPC-D) in 2017.

The topic generating the most passion and discussion concerned the future of the PSEI, especially related to financial issues. The future of Camp Carew is being considered, particularly with respect to how staff are to be funded.

In the worship service Rev. Jason Schiller brought up an interesting point. The church in 2019 is spending a lot of time pondering “things were so good in the 1950s. What’s gone wrong?” Maybe the question should be rephrased: “What did we do wrong in the 1950s, such that our children can’t see their need for the church today?”—*Rita Torrey, Commissioner to PSEI*

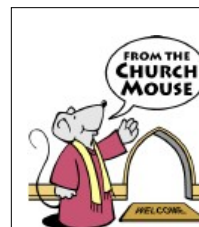

## The Battle of the Schools

A trial that shook Danville to its foundation was that of Fithian vs. Casseday at the October term, 1851. William Fithian MD was the plaintiff; George W. Casseday, an early settler, was the defendant. The suit rose over the erection of two seminaries.

In 1850 the Danville Seminary, called the Red Seminary, was incorporated by member of the Methodist Church and constructed at Main and Pine Streets. Immediately thereafter some members of the Presbyterian Church started another seminary at the northeast corner of Vermilion and Seminary Streets, which they called the



White Seminary. A bitter rivalry developed between these two schools, and they frequently engaged in personal quarrels. Casseday of the Red Seminary wrote an article attacking Dr. Fithian, whereupon the doctor filed a libel suit for \$25,000.

When the case came to court, there was assembled in our old brick courthouse the most brilliant array of counsel ever to appear in one case in the county. Three-hundred pound David Davis of Bloomington was the presiding judge. Abraham Lincoln, Usher F. Linder and Oliver L. Davis filed the suit for Fithian. Casseday's counsel was Hannegan, Peters, Murphy and Lamon. (The Lincoln-Lamon partnership had not yet been formed.) Edward A. Hannegan was one of the most eloquent orators of his day, had served in Congress, and had been a minister to Russia.

When Samuel G. Craig, circuit clerk, called the case, the courtroom and corridors were jammed and hundreds were in the public square. The jury list selected contained the names of many pioneer families.

A fourteen-page declaration filed in this suit is in the very legible handwriting of O.L. Davis. Part of one count says: "Whereas the said defendant, contriving, and wickedly and maliciously intending to injure the said plaintiff in his good name, fame, and credit and to bring him into public scandal, infamy and disgrace with and amongst his neighbors and other good and worthy subjects of this government, did on the 20<sup>th</sup> day of May, 1851, falsely, wickedly, and maliciously, compose and publish of ad concerning said plaintiff, a certain false, malicious and defamatory libel, in which he said; 'Now suppose, Doctor, I was to ask you if you ever

abandoned the corpse of your wife at Paris and left her to be buried at the mercy of others. Tell me not that your son was sick at Georgetown and that you left your wife unburied in order to come here and attend him. I well know your son was sick, but I know also that when you reached Georgetown you found your son was well, but you had time to come to Danville before returning to Paris to be present at the funeral solemnities.

"Now, Fellow Citizens, Whigs, Democrats, I ask you, would Fithian have laid down and slept securely if a political election had been on hand, in place of a dead wife, and his presence had been wanting in Paris. I fancy I hear the answer coming up in thunder tones from every voter in the district. No, sir. He would have mounted his horse and with an energy and perseverance almost superhuman he would have faced fire and tempest in order to be there. He would have had no more rest or peace of mind than he enjoyed when his blooded pigs fell under Uncle John Morgan's cellar and Mr. Woodbury could not find them. Go then and cast yourself down at her grave; water the green sod with tears of regret and penitence; then perchance Heaven may forgive you for abandoning the lifeless body of her who now lies in yonder graveyard. Fellow citizens, Dr. Fithian should be frowned upon by every good and virtuous man and woman for thus forsaking the corpse of her whom he had sworn at the altar of Hymen to love and to cherish."

Ninety-five witnesses had been subpoenaed: Methodists, Presbyterians, and some without church affiliation. Included were such well-known Vermilion County names as John Tincher, Samuel Frazier, W.W.R. Woodbury, Amos Williams, Eli Helmick, William Bandy, Solomon Gilbert, John Cassady, Josiah Sandusky, Fannie Kingsbury, William J. Allen, Abram Mann, Joseph Gundy and scores of others.

Examination of the witnesses concluded, the courtroom resounded for hour upon hour with the ringing voices of the great orators addressing the jury. The jury returned a verdict for the plaintiff, Dr. Fithian, and assessed damages in the amount of \$547.90.

The defendant Casseday paid the judgment promptly, and then for several years thereafter he would list on his personal property tax schedule, "The character of Dr. Fithian, \$547.90, which I bought and paid for."

*(Contributor's Note – Converting 1851 dollar values to today, the suit was filed for approximately \$363,000 and the amount awarded was approximately \$17,400.)*
